

# **OPL Board of Trustees' Meeting Minutes**

### 1. CALL TO ORDER

The Omaha Public Library Board of Trustees met on Wednesday, November 20, 2024 at the Florence Branch, 2920 Bondesson Street. President Mullen called the meeting to order at 5:00 P.M.

The President, or presiding officer, may use reasonable discretion to limit or extend a speaker's time to avoid redundancy, to assure a thorough public discussion on matters before the Board, and to end discussion.

# 7. Director's Report

Laura Marlane, Executive Director, appeared and spoke, highlighting items from her report.

# 8. Advisory Committee Report

President Mullen gave a brief update on the <u>Central Library</u>. The <u>Omaha World-Herald</u> ran a brief story on November 15 about the construction progress. She stated that the Advisory Committee met on October 18.

# 9. PR Committee Report

Trustee Hein-Wang mentioned the <u>Omaha World-Herald</u> story that ran on November 15. The PR Committee met on November 14 and discussed the construction progress. Of the 242 artists who applied to the Central Library's call for public art, 16 artists were selected. The details are available on the <u>Central Library's website</u>.

# 10. Board President Report

President Mullen stated she and Ms. Marlane have designated Trustees Hein-Wang and Reddick to be the Douglas County Liaisons for the Omaha Public Library Board of Trustees, with the hope that the Liaisons can attend County Commissioners' meetings twice a year to give updates. They will attend the County Commissioners' meeting on Tuesday, January 28.

She added that work on the proposed Board Committee Charters continues, and she anticipates that the Board will vote to approve the Committee Charters at the Board's January meeting.

President Mullen continued, stating that she has not heard from Deputy Chief of Staff/Communications, Carrie Murphy, regarding filling the vacant seat on the Board of Trustees.

The Board will go into Executive Session at their January meeting to discuss Ms. Marlane's review.

### 11. Friends of Omaha Public Library

E.C. Schroeder, Secretary of Friends of Omaha Public Library, appeared and spoke, highlighting items from his report.

# 12. Omaha Public Library Foundation

Wendy Townley, Executive Director of Omaha Public Library Foundation, appeared and spoke via Zoom, highlighting items from her report.

# 13. Library Liaison Reports

Trustee Frost stated that her book club took advantage of the <u>Library's Book Club Bags</u> at their last meeting.

Trustee Arriaga stated that she really enjoys the <u>Library's Spanish podcast, Libroteca</u>, and she has been sharing it with her contacts.

# **PUBLIC INPUT, COMMENTS, AND QUESTIONS**

President Mullen stated that any member of the public may address the Board on a topic of relevance to the Omaha Public Library, after identifying themselves by name and address for public record. Persons are to be brief and to limit themselves to five minutes or less. The President, or presiding officer, may use reasonable discretion to limit or extend a speaker's time to avoid redundancy, to assure a thorough public discussion on matters before the Board, and to end discussion. Trustees may engage in questions and discussion of any topic presented, but any desired action will be placed on a future agenda.
